2. Quality Policy

The aim of *FALCO Zrt.* is to completely fulfil the all-time requirements, and to meet the concrete demands of customers, furthermore particularly those of **IKEA and the California Code of Regulations and German Chemikalien-Verbotsverordnung, 995/2010 EUTR regulation, 1907/2006 REACH** & requirements of the **FSC-STD-40-004 Version 3-1 EN FSC Standard for Chain of Custody Certification** & the **FSC-STD-40-005 Version 3-1 EN STANDARD FOR COMPANY EVALUATION OF FSC CONTROLLED WOOD standards, FSC-STD-40-007 V2-0 EN Sourcing reclaimed material for use in FSC Product Groups or FSC Certified Projects** and the **& PEFC ST 2001:2020 PEFC Logo usage rules – Requirements**, furthermore parallel with the **our Environmental Management System in acc. to MSZ EN ISO 14001:2015 std. and MSZ EN 15358:2011 (SRF) system requirements.**

Production, *treatment* and trading of the *MSZ EN 312:2011* particle board (E-LE) happen, in **FSC MIX Credit, or FSC Controlled Wood & PEFC Certified - or PEFC Controlled Sources** system in according with the above-mentioned standards. **See: 2/A Wood purchase policy!**

The formaldehyde emission of the particleboard (E-LE) products at CARB-EPA marked products are lower than QCL and limit values of IKEA-IO5-MAT-0003 AA-10899-15 (2020-07-06), and CCR, title 17, 93120.2(a) Phase 2 and EPA TSCA Title VI. (MSZ EN ISO 12460-5:2016 Perforator-value $\leq 4,00$ mg/100 g board (@6,5%MC) and ASTM D 6007-14, or ASTM E 1333-14 emission $< 0,09$ ppm), or at GPCO marked products are lower than QCLs and limit values of the IKEA-IO5-MAT-0181 AA-218346-3 (2020-07-06) and the German Chemikalien-Verbotsverordnung (MSZ EN 16516:2018 emission $< 0,1$ ppm and MSZ EN 717-1:2005 emission $< 0,05$ ppm).

- performs the methodical development of the quality approach of its workers.


